## III. HAZARDS IDENTIFICATION

**Routes of Entry:** Absorption., Inhalation, ingestion, skin, eyes.  
**Medical Conditions Aggravated:** Skin disease including eczema and sensitization. Respiratory disease including asthma and bronchitis. Eye disease. Kidney disease. Liver disease. Digestive tract disease.

### Immediate (Acute) Health Effects

**Inhalation:** Irritation may be delayed for several hours. Can cause severe respiratory irritation, dizziness, weakness, fatigue, nausea, headache and possible unconsciousness.

**Skin Contact:** Substance causes moderate skin irritation. Continued or prolonged contact may irritate the skin and cause a skin rash (dermatitis). Moderately irritating to the skin. Can cause minor skin irritation, defatting, and dermatitis.

**Eye Contact:** Can cause irritation. Can cause moderate irritation, tearing and reddening, but not likely to permanently injure eye tissue. **Long-Term (Chronic) Health Effects:**

**Carcinogenicity:** OSHA. Contains a substance that is a probable cancer hazard based on human studies.

**Reproductive and Developmental Toxicity:** Possible reproductive hazard. A component in this product has been shown to cause birth defects and reproductive disorders in laboratory animals at doses that could be encountered in the workplace.

**Fire Hazards:** Empty containers that retain product residue (liquid, solid/sludge, or vapor) can be dangerous. ## **VI. ACCIDENTAL RELEASE MEASURES**

**Storage:** Store in a cool place in original container and protect from sunlight. Keep away from heat, sparks, and flame. Keep away from sources of ignition. Do not store in direct sunlight. Store in a cool dry ventilated location. Isolate from incompatible materials and conditions. Keep container(s) closed.

## **Protective Equipment**

### **Respiratory Tract:**
