III. HAZARDS IDENTIFICATION

Routes of Entry: Absorption., Ingestion., Contact., Inhalation and skin.
Medical Conditions Aggravated: Respiratory disease including asthma and bronchitis. No medical conditions affected by exposure. Eye disease. Skin disease including eczema and sensitization.

Immediate (Acute) Health Effects

Inhalation: Can cause severe respiratory irritation. Can be corrosive to the respiratory tract causing severe irritation and tissue damage.

Skin Contact: Contact causes severe skin irritation and possible burns. Corrosive to skin tissue. Can cause chemical burns.

Eye Contact: Corrosive. Will cause eye burns and permanent tissue damage. Corrosive to eye tissue. Can cause severe irritation, tearing, and burns that can quickly lead to permanent injury including blindness.

Skin Absorption: Harmful if absorbed through the skin. May cause severe irritation and systemic damage. No absorption hazard in normal industrial use.

Ingestion: Corrosive to tissue. Can cause severe and permanent damage to mouth, throat, stomach. Aspiration may lead to lung damage.

Long-Term (Chronic) Health Effects:

Carcinogenicity: None of the substances have been shown to cause cancer in long term animal studies. Not a carcinogen according to NTP, IARC, or OSHA.

Mutagenicity: No data available to indicate product or any components present at greater than 0.1% is mutagenic or genotoxic.

Inhalation: Upon prolonged and/or repeated exposure, can be corrosive to the respiratory tract causing severe irritation and tissue damage.

Skin Contact: Prolonged skin contact causes burns. Upon prolonged or repeated contact, corrosive to skin tissue. Can cause chemical burns.

Eye Contact: Upon prolonged or repeated contact, may become corrosive to eye tissue. Can cause severe irritation, tearing, and burns that can lead to permanent injury including blindness.

Skin Absorption: Upon prolonged or repeated exposure, harmful if absorbed through the skin. May cause severe irritation and systemic damage.

IV. FIRST AID

Inhalation: Remove to fresh air. If breathing becomes difficult, give oxygen and get medical attention. Remove to fresh air. Get medical attention immediately. Eyes: Flush eye with water for 20 minutes. Get medical attention. Flush eyes with plenty of water for at least 20 minutes retracting eyelids often. Tilt the head to prevent chemical from transferring to the uncontaminated eye. Get immediate medical attention. Immediately flush eyes with plenty of water for at least 20 minutes retracting eyelids often. This corrosive material can cause immediate and permanent eye damage. Tilt the head to prevent chemical from transferring to the uncontaminated eye. Get immediate medical attention and monitor the eye daily as advised by your physician.

Skin Contact: Wash with mild soap and water. If irritation occurs get medical attention. If clothing is contaminated, remove and wash before reuse. Wash with soap and water under a drench shower. Remove contaminated clothing, launder immediately, and discard contaminated leather goods. Get medical attention immediately.

Ingestion: Drink 3-4 glasses of water and DO NOT induce vomiting. Do not give anything by mouth to an unconscious or convulsing person. Get medical attention. Do not induce vomiting. Give milk or water. Get immediate medical attention. Careful evacuation of stomach by medical personnel imperative. Do not induce vomiting and seek medical attention immediately. Drink two glasses of water or milk to dilute. Provide medical care provider with this MSDS. Corrosive. Do not induce vomiting! Drink one glass of water followed by milk if available. Seek medical attention immediately and give the medical care provider this MSDS.

V. FIRE FIGHTING MEASURES

Flammability Summary:

Fire Hazards: Strong oxidizer. Contact with other combustible material can cause fire.

VI. ACCIDENTAL RELEASE MEASURES

Gather and store in a sealed container pending a waste disposal evaluation.

VII. HANDLING AND STORAGE
