III. HAZARDS IDENTIFICATION

Routes of Entry: Inhalation., Ingestion., Skin contact., Eye contact.
Medical Conditions Aggravated: Respiratory disease including asthma and bronchitis. Eye disease.

Immediate (Acute) Health Effects

Inhalation: May cause irritation of the respiratory tract. Can cause minor respiratory irritation, dizziness, weakness, fatigue, nausea, and headache.

IV. FIRST AID

Inhalation: Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get immediate medical attention. Remove to fresh air. If breathing is difficult, have a trained individual administer oxygen.
